ORDINANCE # 384

AN ORDINANCE REPEALING ORDINANCE NO. 382 RELATING TO VEHICLES AND TRAFFIC BY THE BOROUGH OF NEWPORT, REPEALING OTHER INCONSISTENT ORDINANCES OR RESOLUTIONS OR PARTS THEREOF; AND REENACTING VEHICLES AND TRAFFIC CHAPTER 237; AND CONTAINING A SEVERABILITY CLAUSE; AND SETTING AN EFFECTIVE DATE.

WHEREAS, the Borough of Newport is a body corporate and political, duly organized and existing in accordance with the laws of the Commonwealth of Pennsylvania and the Borough Code, Title 8, PA C.S. §101 et seq. (the Borough Code); and

WHEREAS, the Borough of Newport adopted Ordinance No. 382 on April 4, 2023, relating to Vehicles and Traffic that provides regulations for vehicles and streets within the Borough; and

WHEREAS, the Borough Council of the Borough of Newport voted to adopt this ordinance; and

WHEREAS, the Borough Council of the Borough of Newport has determined that it is in the best interest of the Borough at this time to repeal Ordinance No. 382.

NOW THEREFORE, BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of Newport as follows:

SECTION 1. Repeal of Ordinance No. 382.

Borough Council hereby repeals Ordinance No. 382 in its entirety.

SECTION 2. Reenact Vehicles and Traffic Chapter 237

Vehicles and Traffic Ordinance Chapter 237 shall be reenacted in its entirety prior to the effective date of April 4, 2023.

SECTION 3. Severability.

The terms, conditions and provisions of this ordinance are hereby declared to be severable, and, should any portion, part or provision of this ordinance be found by a court of competent jurisdiction to be invalid, non-enforceable or unconstitutional, the Council hereby declares its intent that the ordinance shall have been enacted without regard to the invalid, non-enforceable, or unconstitutional portion, part or provision of this ordinance.

SECTION 4. Effective Date.


This Ordinance shall take effect and be in force on the earliest date permitted by the Borough Code.


