ORDINANCE NO. 388

AN ORDINANCE AMENDING ORDINANCE NO. 348, CHAPTER 237, VEHICLES AND TRAFFIC, RELATING TO, ONE-WAY STREETS DIRECTION SOUTH ON LOCUST STREET, PARKING TIME LIMITED IN CERTAIN LOCATIONS WEST ON PENN AVENUE, SPECIAL PURPOSE PARKING ZONES ESTABLISHED; PARKING OTHERWISE PROHIBITED WITH A HANDICAP PARKING SPACE ON 4TH STREET, UNLAWFUL TO PARK VEHICLE ON STREET FOR MORE THAN FOUR DAYS, AND VIOLATIONS AND PENALITES ARTICLE III, TO SET FINES FROM TIME TO TIME BY RESOLUTION.

WHEREAS the Borough of Newport is a body corporate and political, duly organized, and existing in accordance with the laws of the Commonwealth of Pennsylvania and the Borough Code, PA C.S. Title 8, §101 et seq. (Borough Code), and

WHEREAS the Borough Council of the Borough of Newport has determined that amendments to this ordinance are necessary; and

NOW THEREFORE, BE IT ORDAINED AND ENACTED by the Borough Council of the Borough of Newport the following amendments to Ordinance 348, Chapter 237, Vehicles and Traffic:

<u>SECTION I</u>: Chapter 237, Article II, Traffic Regulations, Subsection 237-10. One-way streets. A. is hereby amending direction of travel on Locust Street as follows:

SECTION II: Chapter 237, Article III, General Parking Regulations, Subsection 237-23. Parking time limited in certain locations. is hereby amended by eliminating two-hour parking in the following location:

Two-hour parking between 8:00 a.m. to 6:00 p.m.

<u>SECTION III</u>: Chapter 237, Article III, General Parking Regulations, Subsection 237-25. Special purpose parking zones established; parking otherwise prohibited. is hereby amended by adding the following:

Fourth Street

One space at

East at 4th ST & Walnut ST

Handicapped parking only

SECTION IV: Chapter 237, Article III, General Parking Regulations, Subsection 237-29. Unlawful to park vehicle on street for more than four days. is hereby amended as follows:

It shall be unlawful for the owner, lessee, bailee or custodian of any motor vehicle, trailer, wagon, boat or any material or object that may block the parking area provided for the streets and/or alleys of the Borough, to park the same on the streets or alleys of the Borough for a period of more than four days without moving same or obtaining permission from the code enforcement officer to extend the period for valid cause. The word moving is defined to mean a bona fide removal from the street or alley. The purpose of this being to promote available parking space and orderly movement of traffic throughout the Borough.

<u>SECTION V</u>: Chapter 237, Article III, General Parking Regulations, Subsection 237-30. Violations and penalties. is hereby amended to set fines by resolution in Article III as follows:

- A. Any person who shall violate any provision in this article, excepting violations of §237-25 (special parking zone) shall, upon conviction thereof, be sentenced to pay a fine set from time to time by resolution of the Borough Council together with the costs of prosecution.
- B. Any person who shall violate §237-25 shall, upon conviction thereof, be sentenced to pay a fine set from time to time by resolution of the Borough Council together with costs of prosecution; however, a person violating the handicapped parking restrictions is guilty of a summary offense and shall, upon conviction be sentenced to pay a fine set from time to time by resolution of the Borough Council together with costs of prosecution, in accordance with state regulations.
